Flood Awareness in the Carson River Watershed

Through a FEMA grant managed by the Carson Water Subconservancy District, River Wranglers visits schools and teaches students about flood awareness. By using such tools as a flood model and a flood relay activity, River Wranglers teaches students how areas around a river are prone to flooding, how to recognize important items to take in the case of an evacuation, and discuss what the students would do in the event of a flood.

The last major flood on the Carson River happened in 2017. In Nevada, we are always at the whim of the weather. Are you prepared in the event of a flood?

River Wranglers is gearing up for a busy spring. With multiple workdays, field days, a Seasonal Changes program, and countless other outreach events on the calendar, we expect to accomplish great things.



From wrapping trees to protect them from beaver damage with Sutro Elementary School in Dayton—to students from Pau-Wa-Lu Middle School learning about Benthic macroinvertebrates with volunteers from Nevada Division of Enivronmental Protection in Dresslerville—to planting pollinator plants with Carson City Parks & Recreation, Open Space with Carson City Boys & Girls Club—to teaching about water quality and sampling at the first annual Carson City Source Water Assessment Day at Kings Canyon, students and community members all along the Carson River will experience the joy of learning outside and exploring their watershed.

Snapshot Day, October 21, 2022

















On October 21, River Wranglers partnered with 30 numerous agency professionals and skilled volunteers to bring Snapshot Day to the Carson River watershed. 175 students of all ages from Carson Montessori School, Sierra Lutheran High School, and Pau-Wa-Lu Middle School gathered at multiple sites along the Carson River to learn about and test the water quality of the river at a specific time, taking a "snapshot" of the river's health in that moment. Data has been captured since 2006 and it is released to teachers and volunteers who have interest in using it.
